

A LETTER FROM THE PRESIDENT

This last year we saw our "body politic" bruised and battered – both on the national front, and in states closer to home. It was a forceful reminder of the vital City Club mission to inform and engage citizens in public issues. We cultivate the citizen capital that is needed to solve the challenges we face in the Portland region and beyond.

As you're reading this, the memory of Washington's dysfunctional debate over the debt ceiling will not have fully faded. In stark (and welcome) contrast, City Club's 2010-11 fiscal year began with former Senator Bob Packwood's prescient cautions on the perils of partisanship, followed by a series of civil candidate debates for the major offices up for grabs in 2010, along with lively ballot measure debates. The Friday Forums, a weekly staple of the Club's wide-ranging programming, featured experts from near and far who educated, entertained and excited us about everything from the politics of scarce water resources to Portland's "indie" music scene. Thousands of members and guests experienced these Forums live at the Governor Hotel; tens of thousands more enjoyed them via our broadcast partners or the podcasts on our website.

One of the year's highlights was the **premier issue series**, (\star) **From Crisis** to Opportunity: Exploring Solutions to Oregon's Fiscal Challenges, on restoring Oregon's fiscal health that Governor John Kitzhaber kicked off in the spring. The series included an array of insightful Forums along with more intimate Agora and New Leaders Council events. These included an interactive exercise to redraw a mock state budget and a tour of urban renewal efforts in Lents. The Club's signature member-led research supported the premier issue series by tackling – without standoffs or dueling sound bites – PERS reform.

Beyond PERS reform, dozens of Club members spent weeks studying, analyzing and crafting recommendations regarding Multnomah County's delivery of mental health care services as well as three ballot measures considered by voters.

It was a year that served once again as a testament to the enduring value and vitality of the Club's mission as THE convener of citizen conversations on the most important public issues.

Finally, the Research program released a comprehensive report on the Public Employees Retirement System.

City Club convenes these important conversations, allowing us to more deeply understand important issues at the local, regional and national levels. Our programs could not happen without the efforts of volunteers who serve on our programming committees of Research, Advocacy and Awareness, Friday Forum, Agora and New Leaders Council. These members dedicate their knowledge, time and passion to ensure Portland has a more informed citizenry. They are the thought-leaders of today.



Final reports are presented to the membership for adoption in a public debate and vote.







REGIONAL

TRANSPORTATION GOVERNANCE

City Club's Advocacy & Awareness Program extends the life and increases the impact of the Club's research reports by engaging members in organized efforts to promote the Club's public policy recommendations. This year, Initiative Reform Committee members wrapped up their advocacy efforts, which - over a three year period resulted in the passage of two bills: HB 2005, which directed additional resources to proactive enforcement of rules governing signature gathering, and HB 2942, which ended the practice of "ballot title shopping." The Forest Park Advocacy Committee helped secure the implementation of more than a half-dozen report recommendations, including the completion of long-promised ecological studies and user surveys, and the hiring of Forest Park's first full-time park ranger. Meanwhile, the Regional Transportation Governance Committee engaged in a remarkable series of public presentations to groups and individuals ranging from Metro to the Mayor of Portland to the Governor's new Transportation Adviser.




