

#### **ACHIEVING ENERGY INDEPENDENCE**

#### June 3, 2011 **Senator Jeff Merkley**

American dependence on foreign oil is not sustainable. The United States possesses only two percent of the world's oil reserves, yet our nation uses a full one-quarter of all the oil produced globally. This reliance on oil-producing nations such as Saudi Arabia, Russia, Iraq, Venezuela and Nigeria not only costs our nation billions, but also aids governments that often act against America's national security interests. Moreover, it prevents the U.S. from investing more fully in homegrown clean energy, while undermining efforts to improve air and water quality.

#### **UNDERSTANDING THE FEDERAL** DEBT AND HOW TO TACKLE IT June 10, 2011

#### **Congressman Kurt Schrader**

Congressman Kurt Schrader will discuss what Congress might do to balance the budget while also tackling our mounting debt.

In the last decade we have seen dramatic increases in federal deficits. The economic downturn and tax cuts have decreased revenue while foreign wars and recent stimulus measures have significantly increased spending. A long-term solution – which will likely require both tax reform and a hard look at our current spending priorities – will be necessary to reduce the gap between revenues and expenditures and also to shrink the federal debt.

Rep. Schrader is the chair of the Blue Dog Coalition's Fiscal Responsibility Task Force, which promotes policies to reduce federal spending and stabilize the nation's mounting debt. A small-business owner, Schrader also serves on the House Committee on Small Business and serves as ranking member of the House Small Business Subcommittee on Finance and Tax.

With the Oregon legislature divided almost equally between Democrats and Republicans, many predicted a political meltdown. Instead, Republican Bruce Hanna and Democrat Arnie Roblanthe first House Co-Speakers in Oregon legislative history-found opportunities for bipartisan action on tough issues facing our state.

#### **REVITALIZING THE ROSE** OUARTER

Since its creation in 1993, the Rose Quarter - and particularly the Memorial Coliseum it houses – has seen turbulent times. Former Rose Quarter management companies have gone bankrupt, the Coliseum has been threatened with demolition, and inertia has plaqued many urban renewal attempts. That this district sits on what was, in the 1960s, a thriving African American neighborhood just makes its lackluster



atmosphere more tragic.

The Oregon State Treasury plays a critical role in securing and enhancing the financial health of the state and its residents. #### **BUILDING A FUTURE FOR OREGON'S HISTORY** September 23, 2011

Kerry Tymchuk, Interim Executive **Director, Oregon Historical Society** 

The future of the Oregon Historical Society was touch-and-go, until voters last November approved a \$1.75 million levy to keep the 112-year-old organization up and running. Then, interim Executive Director Kerry Tymchuk lobbied the legislature for additional funding – and in July, received \$2.5 million in state lottery dollars to pay off a looming mortgage debt, freeing the historical society to plan for the future.

#### WHAT'S NEW AT METRO September 30, 2011 **Tom Hughes, Metro Council President**

Metro Council recently received state approval for its fifty-year urban and rural reserve plan, establishing an unprecedented long-term land-use strategy for the Portland metro region. This reduced the likelihood of bitter intercounty squabbles - which previously took place every five years – over which lands would be developed and which parcels would remain rural.

#### **1ST CONGRESSIONAL DISTRICT DEMOCRATIC PRIMARY DEBATE**

#### Brad Avakian, Suzanne Bonamici and **Brad Witt**

Congressman David Wu's August resignation opened the door to challengers for one of Oregon's most dynamic political regions: Oregon's 1st Congressional District. The unique character of this district - with its urban and rural areas, increasingly high-tech economy and growing racial and ethnic diversity – means that the challenges facing the district often directly reflect the nation's most pressing issues.

Candidates Brad Avakian, Suzanne Bonamici and Brad Witt will debate for the right to represent 1st District Democrats in January's special election. Candidates will answer tough questions about how best to lift the nation out of its economic doldrums; tackle a growing national debt; deal with threats to national security; and more.

If Portland had the same per capita income as Seattle, Multnomah County schools would have \$86.6 million in additional funding.

These are staggering facts made even more threatening by the state of our local economy. Yet, there is a bright spot. Greater Portland is an export powerhouse It ranked second in the nation in growth in value of exports between 2003 and 2008 - and our traded sector is poised for expansion, if we take the right steps now. Some 330,000 times a day, someone steps on to a TriMet bus, MAX light rail or WES Commuter train. While TriMet, the state's largest transit agency, provides a critical service to our region, the agency is now facing a budget shortfall of up to \$17 million. To balance this deficit, TriMet is considering service cuts and higher fares, but also more drastic actions, such as ending the city's iconic Free Rail Zone and eliminating single-ticket round trips.



#### **STATE OF THE CITY** March 2, 2012 **Mayor Sam Adams**

Throughout Mayor Sam Adams' time in office, Portland has faced significant challenges, including a struggling economy, poor high school graduation rates and persistent inequality. There are, however, some signs of improvement. Unemployment rates in the Portland metro area have dropped below the national average and graduation rates within Portland Public Schools have risen five percent over the last year.

#### TRANSPORTATION. TIMBER AND WHAT'S NEXT IN DC March 9, 2012

#### **Congressman Peter DeFazio**

America's transportation infrastructure investments seriously lag behind those of competitor nations. The US spends under one percent of its GDP on infrastructure including transportation – far less than either China or India. Meanwhile on the back roads, rural counties are struggling. Federal funding for forested communities have helped support Oregon's rural counties for over a decade. With this funding, including county and timber payments, expiring, rural counties face severe impacts to their public services and some may even go bankrupt.

## **MEMBER PROFILE**

#### PAUL MEYER Retired Attorney MEMBER FOR 60 YEARS!

For sixty years, attorney Paul Meyer, founder of ACLU's Oregon chapter, has been engaged in City Club – a participant in many influential research projects and an active proponent of City Club's admission of women in the 70s.

Paul joined City Club in 1954 as a newly-minted lawyer – "socially and politically conscious." He calls City Club one of the best ways to participate in the civic life of Portland, and that is what drew him to join.

From his early days with City Club, one of his most memorable experiences was serving on the long-term research committee that examined the best form for Portland city government – culminating in the 1961 report called Portland City Government (available here: http:// pdxcityclub.org/content/portland-city-government). Paul was involved with forming some of the follow up committees for that report.

Another highlight of Paul's years at City Club was living through the gender desegregation of its membership, or "the fight to admit women." He describes a committee hearing, empassioned speeches, and repeated votes – all in the effort to earn passage of a bylaws amendment to allow women to join the club.

More recently Paul participated in the two-year study of the Portland Development Commission. The study produced a 2005 report reversing City Club's recommendation in 1971 that the agency be dissolved. More than 30 years later Paul co-authored the updated report that called the PDC a "unique and powerful tool" while also calling attention to the need for the agency to increase transparency and public involvement. www.pdxcityclub.org/content/portland-developmentcommission-governance-structure-process.

Paul also participated in the 2012 ballot measure committee looking at Measures 81 and 83 related to casinos on Oregon.

During 2011–2012 over 40 members gathered weekly to conduct research and lead conversations about four topics of great relevance for our region: Political Redistricting; Civics Education in our high schools; the role of Bicycle Transportation in our community and Air Quality Regulation in the Portland metro area.

Upon completion of the first two reports, City Club members voted to adopt the committee recommendations. Advocacy committees were formed so that the Club could continue to represent the membership while convening and leading conversations with our state's most influential elected and community leaders. The third and fourth reports are due for publication in the winter and spring of 2013.

Research reports and recommendations are the result of 12 months of focused interviews, hundreds of hours of independent research, weekly member-to-member debates and continual critical analysis of competing priorities. All of these activities take place in the pursuit of finding bipartisan, unbiased consensus for a committee recommendation.

Once a recommendation is adopted by the committee and later by the membership, the real work of advocating for the recommendations in the public arena begins.

#### LINES THAT DON'T DIVIDE: A CITY **CLUB OF PORTLAND REPORT ON IMPROVING OREGON'S REDISTRICTING PROCESS**

#### **Report approved by City Club members** unanimously

The Oregon Legislature's successful 2011 redistricting effort was due to an

unusual set of circumstances, including close cooperation between Republican and Democratic leaders, and a desire to keep the process out of the hands of the secretary of state. Even so, redistricting under the control of the Legislature is inherently partisan, and the results are frequently attacked as biased, whether true or not.

The committee recommended an independent, nonpartisan commission as the best and most effective way to improve Oregon's redistricting process in the long term because it would eliminate the conflict of interest inherent in the present system as well as the potential for partisan abuse.

The committee further suggested that the current Legislature should act guickly on the recommendation in order to capitalize on the cooperative individuals holding office. In the face of increasing polarization of national and state politics in the country, Oregon may have only a limited window to adopt a nonpartisan redistricting process while our Legislature is made up of lawmakers who put the state's interest ahead of partisan politics.

#### **EDUCATING CITIZENS: A CITY CLUB REPORT ON IMPROVING CIVICS EDUCATION IN PORTLAND'S HIGH SCHOOLS**

**Democracy** requires citizenship - the knowledge of history and how government works, the critical

This report concluded with eight specific recommendations for the Portland Public School District, the Oregon Legislature, the Oregon Department of Education, and all of Portland's local governments and civic organizations. All recommendations were for local action steps that would target youth involvement while communicating a clear commitment to the preparation for citizenship as a fundamental priority for a functioning

This report also includes a summary of five common elements of a school that promotes civic engagement and six proven practices for promoting civic

In an effort to elevate the community's conversation about the importance of engaging the next generation of citizens and civic leaders, City Club organized its first full day summit and dedicated the day toward building intergenerational

#### **BICYCLING IN PORTLAND:** A SERIOUS LOOK AT **TRANSPORTATION POLICY AND PRIORITIES**

While Portland enjoys a well-deserved reputation as one of the top bicyclefriendly cities in the nation, any plans to expand the city's network of bikeways will no doubt require addressing a number of funding, public safety and community challenges. This study committee is charged with examining what role bicycling should play in Portland's overall transportation system, while also making recommendations to address these specific challenges.



#### **AIR OUALITY REGULATION** IN THE PORTLAND **METROPOLITAN AREA**

Despite Portland's reputation as a clean air leader, major questions have been raised in recent years about the region's air quality, especially as it relates to airborne carcinogens. This study committee is charged with: (1) evaluating such claims and (2) identifying ways that environmental and health agencies, industry, transportation and public interest groups can work together to improve the air quality regulatory process.

Members work through City Club's Advocacy & Awareness Program to enact the recommendations of City Club Research Committees that have been overwhelmingly approved by Club members. Two committees worked diligently on past reports during this period: the Forest Park Advocacy Committee and the PERS Advocacy Committee.

The Forest Park Advocacy Committee represents some of the most successful advocacy work the Club has undertaken. In its first year of work, the Committee accomplished half of the recommendations outlined in the report. During the 2011-2012 fiscal year, committee members continued to raise awareness about the importance of Forest Park through City Club programming and meetings with leaders who's decisions affect the future of this treasured resource.

Members of City Club's PERS Advocacy Committee appeared before the PERS board and met with state policy leaders to urge action that would ensure a viable system that serves future retirees responsibly and sustains the quality of our public services. Their work has garnered statewide media attention, and stirred state leaders into action on this seemingly intractable issue.

Advocacy committees were also formed to promote the recommendations of the Redistricting and Civics Education reports, and members are reporting many early successes as they work to accomplish their goals.

JAMES OFSINK Financial Aid Officer Portland State University

#### **MEMBER SINCE 2010**

Passionate about civic engagement and electoral issues, James Ofsink admires City Club as a group that can really affect change. He says, "In my generation there's a bit of apathy... a sense that the system is rigged against you. People may be right, but the response shouldn't be disengagement."

In his relatively brief time as a City Club member, James has gotten involved with the New Leaders Council as well as the research committee looking at the process Oregon uses for redistricting. As part of that committee, he and other members spent a year interviewing experts about redistricting.

The committee presented its recommendations during a Friday Forum presentation, with Congressman Blumenauer present. No known corruption has taken place using the current redistricting process – but the committee found that conditions are ripe for corruption, and reform of the redistricting process is needed in order to prevent it.

The report garnered the requisite number of votes from City Club members, and now James has embarked on advocacy. He says, "Now that you've studied, you're an expert!" He's chairing the redistricting advocacy committee and reports it has a champion for a bill in the state legislature.

James is enthusiastic about the "strength of citizen-driven research." He says there were 12 people on the research committee – from all walks of life, screened for conflict of interest, and no one with a hidden agenda. They debated would agree to disagree, but through writing majority and minority reports, came out with a report that everyone could get behind. James says he'd love to see this style of democracy from elected officials at the federal level.

James is thrilled with the way City Club works. He says, "If you are a member and are passionate about something you can make it happen; the agenda isn't set by the board and the staff. The Club is surprisingly not top-down. If you have a good research or program idea and are passionate about it, and if you can convince other Club members to work with you – you can bring your idea to life!"

As for the future, James would love to see his advocacy committee through to success, and stay involved with New Leaders Council as well.

Although she might be more accustomed to working amid professionals than the average undergraduate (Chelsey worked in a corporate law firm in Bend during her last years of high school), she still valued the opportunity to work with a diverse cross-section of Portlanders during the intensive research experience this summer.

Her experience with City Club has also helped her with her full-time internship with Drive Oregon – the nonprofit that supports the hybrid and electric vehicle industry in Oregon. Chelsey says that her experience with City Club has strengthened her research skills, and meeting participation and note-taking skills at Drive Oregon.

As a poli-sci major, Chelsey also loves thinking in real terms about local politics – and realizes the influence that citizens can have on local decisionmaking. Chelsey says that even though she didn't think casinos could affect her personally – because she doesn't gamble – she discovered that casinos do have enormous economic impacts, both positive and negative.

Chelsey is grateful for the opportunity to explore a public issue at close range – especially an issue that seemed out of her realm. Looking forward, she hopes to have another chance to work on a research committee, as well as get involved with New Leaders Council. 



The Club's endowments are held by the Oregon Community Foundation (OCF) in its main long-term investment pool. The Club is also the beneficiary of two designated funds at OCF (Don Sterling and Goldy Family), not shown here.

Annual distributions from the endowments support the Club's operating budget and, in the case of the Research Endowment, the Club's research function within the operating budget.

Currently the distribution rate set by OCF is 4.5% of the average endowment balance over the previous 13 quarters, adjusted for additions.


