PRESIDENT'S LETTER

It has been a great honor to serve City Club as your president over the past year. This 103-year-old institution means a lot to me and I'm proud of the work we've done to strengthen our position as a leading civic organization in our region.

City Club's governors, staff, and the dozens of volunteers who produce our forums, lead our research, and drive our advocacy have accomplished so much in just 12 months.

In February, we published a research report that focused on whether Portland's city government equitably represents all Portlanders. That report, and the public education campaign that continues today, may prove to be the most consequential work City Club has undertaken since we inspired the formation of Forest Park. City Club's research board, advocacy board, and the amazing Stacey Rice worked closely with a committed and determined research committee to produce a report that powerfully shows the structural roots of Portland's failure to equitably and efficiently serve all Portlanders.

This winter, we also launched a new organizational membership program that creates new pathways for businesses, nonprofits, unions, and public entities to participate in our community. Michelle Mercado, in collaboration with City Club's membership committee, did an incredible job of shaping this program and recruiting civic-minded organizations to join. This program was part of an overall increase in new memberships and a trend toward a bigger and more engaged City Club community. I've also been excited about how we've continued to sharpen our vision and our voice as an organization committed to inclusion, independence, and justice. Our community has a clearer understanding of what City Club stands for and is energized to support our work in part thanks to our communications director, Dan Rivas.

And we finished the budget year with a tidy surplus and in a strong position to tackle the work ahead thanks to the development, finance, and gala committees, but especially thanks to Julia Meier, who has brought unshakeable leadership to both the fiscal and programmatic sides of City Club.

Serving as City Club's president is both humbling and enriching. I've been grateful for the frequent opportunities to question my assumptions and authentically engage with people who disagree with me. I'm grateful for the friendships I've gained over the past year. Most importantly, I'm grateful to be part of a community where we can grow into our best selves.

Two years ago, City Club's Board of Governors adopted three core values for our organization—inclusion, independence, and justice.

Each of those values has roots in the very earliest days of City Club. We were founded by community leaders who felt the city was not responding to the concerns of everyday people and that Portland needed an independent voice to hold our governments accountable.

Today, we're seeing how much further we can go with these values as our guide.

Last year, individual membership grew by more than 25 percent. Through sponsorships, organizational memberships, and partnerships more than 60 organizations made a financial contribution to City Club in the past year. And more than 200,000 people attended, watched, or listened to a Friday Forum last year.

Our growing community is translating into a bigger impact in Portland and across the state.

In 2018, we published four ballot measure research reports, one ballot measure

resolution, and five statements in the Voters' Pamphlet. Thousands of Oregon voters considered our research recommendations before casting their votes and on election day we saw that Oregon voters agreed with City Club on all five ballot measures.

Six months later, in February, we released a comprehensive research report that recommended ending Portland's inequitable commission form of government. Our report release event sold out the Alberta Rose Theatre and nearly every local media outlet reported on our research findings. In the days and weeks after that release, many Portlanders spoke up about the failures of our current system. Today, Portland is energized for change. We've sparked a movement that's building momentum and are looking forward to continuing the work. We've accomplished a lot this year and are excited about the opportunities ahead.

Right now, we're deep into a strategic planning process that is helping us take a fresh look at our programs, our mission, and our role in the civic life of today. This process includes plans to reshape our events calendar to better meet the needs of the City Club community.

We've begun to see what's possible with an open, inclusive, and more courageous community. Thank you for helping us grow and evolve into the City Club our community needs and deserves.

PROGRAMS

Not a day goes by when I don't marvel at the fact that we've been doing research and forums for 103 years. It's an incredible legacy that I'm honored to play a role in continuing as your program strategist.

This year, we've continued to evolve our programming, building on the wonderful history of this organization. Portland is changing and we're hearing from a lot of you about how our programming can better respond to the needs of today's civicallyengaged Oregonian.

City Club has a long history of meeting on Friday at lunch. In fact, the very first official City Club meeting was a Friday lunch in October, 1916. Surprisingly little has changed since then. In the late spring of 2019, Sharon VanSickle-Robbins and Meredith Savery undertook a research project to consider new ways to think about City Club events. The result of that research was a new events calendar and a slightly different approach to some of City Club's events, which we'll roll out in September.

This year we also saw the power of City Club research to spark important conversations about major policy ideas.

In February, we launched a comprehensive research report that consider whether Portland's form of government equitably represents Portlanders. The release of our research was met with enthusiastic interest across Portland and beyond. Nearly every major media outlet reported on our research, three publications printed op-eds in support of our research recommendations, and a community event to highlight the report's findings through the stories of various community leaders sold out the Alberta Rose Theatre. We've now begun additional research to build on our recommendations and to give leaders the tools they need to work on a new system of government.

Our ballot measure research also made a difference in Oregon. In August of 2018, we published four ballot measure reports and one ballot measure resolution and included statements in the 2018 Oregon Voters' Pamphlet.

These are just a few of the examples of City Club's impact thanks to the many members and volunteers who give of their time and expertise to inform the public. Words cannot express the deep appreciation we have for all that you do to lead and support this work.

Research

City Club's research program continues to be a valued source for fair, accurate, nonpartisan information about issues facing the Portland Metro region and Oregon. Our research board oversees the work of our research committees to ensure the work meets the high standards of City Club and its members.

City Government Research Report

Our latest research report titled "New Government for Today's Portland: Rethinking 100 Years of the Commission System" was approved by the research board and Board of Governors and published in February 2019. This was the culmination of nearly two years of effort by the research committee tasked with researching this issue.

Alternative Voting Methods Research Committee


In our research report, "New Government for Today's Portland: Rethinking 100 Years of the Commission System," the research committee identified areas for further study. One of those areas was alternative methods for electing city council members. A research committee was formed in June 2019 to research this issue and will report its recommendations early in 2020.

2018 Ballot Measures

The research work on four ballot measures and one resolution was wrapped up last summer. This work was rolled out and debated at our Ballotpalooza event held in August 2018. All of the ballot measure and resolution recommendations were approved by City Club membership.

The ballot measure reports include:

- Measure 103: A Ban on Grocery Taxes
- Measure 105: Repeal of Oregon's
 "Sanctuary" State Law
- Measure 106: A Ban on Public Funds to Be Used for Abortion (Resolution)
- Metro Ballot Measure: Bonds to Fund Affordable Housing
- Portland Clean Energy Fund: Surcharge on Retailers to Fund Clean Energy and Job Training

Advocacy



City Club continues to advocate for the truths uncovered in our research reports. Below is a summary of our advocacy work this year.

City Government Research Report

In the past, after members voted to approve a report, City Club would form an advocacy committee to advance the recommendations in that report.

The complexity of the advocacy work required to change Portland's system of government, combined with the equity focus of this work, required City Club to take a different approach to advocating on this issue.

The advocacy board, in collaboration with staff and other program board members, developed a community engagement plan that focuses on City Club playing a role as a presenter that could educate and engage the public about this issue and as a convener that brings together interested stakeholders to work together on an approach to changing Portland's system of government.

This advocacy work is ongoing and will be a significant focus for the coming year.

Ballot Measures

The advocacy board helped plan a series of Friday Forums on the 2018 ballot measures and composed voter pamphlet statements for the ballot measure research approved by City Club members.

Earthquake Resiliency

This committee continues to advocate for the recommendations in the 2017 research report, "Big Steps Before the Big One: How the Portland area can bounce back after a major earthquake."

The committee has been meeting for two years and recently it issued a progress report on the original research report's recommendations. Nine recommendations out of a total of fourteen have been completed.



Friday Forums

We held 43 forums in 2018-19 with the two highest attended forums being the State of the County (500 attendees) and "How Oregon is Failing Black Students" (470 attendees). Our digital audience averages more than 5,000 views per event.

The forums covered a wide range of topics and several topics were addressed in multiple forums. We hosted series on homelessness, aging, the state budget crisis, and Portland's form of city government. We also held a State of the State event with Governor Kate Brown, a State of the Region with Metro Council President Lynn Peterson, State of the County with Multnomah County Chair Deborah Kafoury, and a one-on-one conversation with Oregon Chief Justice Martha Walters.

Beginning this spring, City Club undertook a major project to rethink the format, logistics, and staffing of City Club events and to come up with a plan for the next generation of events at City Club. This work has included interviewing and surveying other City Clubs across the US, interviews with current and former staff, and focus groups with event stakeholders. As part of the process to gather feedback and ideas, we conducted an audience survey that focused on event logistics and that resulted in more than 300 responses.

Our ability to put on 43 forums in one year is only possible thanks to the incredible commitment and passion of the members of the Forum Board. A position on the Forum Board is very demanding, but our forum producers never fail to deliver.



MEMBERSHIP

It's been so much fun seeing so many of you throughout the year at City Club events. I love that a big part of my job is spending time with this community and getting to know who you are and what you care about.

For me, what makes City Club special is that it's a place where anyone can connect with other people who also care about the big questions. And those opportunities to connect continue to grow.

This year, our membership grew by about 25% and continues to diversify, especially among groups that have traditionally been underserved by City Club. Our members come from many different backgrounds, but what brings us together is our shared vision of an inclusive community where we can ask difficult questions and discover proactive solutions to big issues.

To better serve the diversity of people and organizations in our community, we've developed an organizational membership program. The more than 15 community partners in our organizational membership program represent nonprofits, businesses, public entities, and labor unions. What they share is a commitment to working together for a better Oregon.

As we reflect on the year ahead, I'd like to thank all of our dedicated volunteers who bring not only their talents, but their passion for civic engagement to City Club. Without you, our work would not be possible. Thank you all for your continued support and I look forward to connecting with you this fall.
